We would like to inform you that when issuing ECMT licences for 2020 in the period from 21 to 31 December 2019, our services that issue them, for technical reasons, in the ECMT EDI information system indicated the date of issue of all permits - December 31, 2019.

We apologize for this inaccuracy and would like to ask that the ITF member states, their supervisory authorities, take this information into account in order to avoid any sanctions against Belarusian hauliers.
