## LAW OF THE REPUBLIC OF ARMENIA ON ROAD CHARGE

Adopted by the National Assembly of the Republic of Armenia on 3 March 1998

## CHAPTER II ROAD TOLL CHARGE TARIFFS

## Article 6. Tariff rates for heavy motor vehicles road passage

1. For the purposes of this Law, heavy motor vehicles shall include vehicles in which at least one of the following characteristics exceeds

gross weight	- 36 tonnes;
single axle load	- 10 tonnes;
tandem axle load	- 18 tonnes;
tri-dem axle load	- 22 tonnes.

Axles in which the distance between neighbouring axes does not exceed 2.5 metres shall be considered tandem and tri-dem axles.

2. Toll for heavy motor vehicles road passage shall be charged in the amount equal to the product of the sum total of tariff rates introduced by this article for the gross weight and axle load of a vehicle and the distance of road passage.

3. Toll for road passage of vehicles with the gross weight of 36 tonnes and more shall be charged for every kilometre of road passage on the basis of the following tariff rates:

gross vehicle weight	rate
36 to 40 tonnes	110 drams
40 to 45 tonnes	130 drams
45 to 50 tonnes	155 drams
50 to 55 tonnes	175 drams
55 to 60 tonnes	220 drams
60 to 65 tonnes	265 drams
65 to 70 tonnes	310 drams
70 to 75 tonnes	375 drams
75 to 80 tonnes	440 drams
80 to 85 tonnes	550 drams
85 to 90 tonnes	770 drams
90 to 95 tonnes	1,100 drams
95 to 100 tonnes	1,540 drams
100 tonnes and more	1,540 drams plus 88 drams for each tonne above 100 tonnes.

4. Toll for road passage of vehicles with single axle load exceeding 10 tonnes shall be charged for every kilometre of road passage on the basis of the following tariff rates:

single axle load	rate
10 to 10.5 tonnes	45 drams
10.5 to 11 tonnes	110 drams
11 to 11.5 tonnes	175 drams
11.5 to 12 tonnes	265 drams
12 to 12.5 tonnes	375 drams
12.5 to 13 tonnes	530 drams
13 to 13.5 tonnes	770 drams
13.5 to 14 tonnes	1,100 drams
14 to 14.5 tonnes	1,430 drams

14.5 to 15 tonnes	1,760 drams
15 to 15.5 tonnes	2,100 drams
15.5 to 16 tonnes	2,400 drams
16 tonnes and more	2,400 drams plus 45 drams for each 500 kg above 16 tonnes.

5. Toll for road passage of vehicles with tandem axle load exceeding 18 tonnes shall be charged for every kilometre of road passage on the basis of the following tariff rates:

tandem axle load	rate
18 to 19 tonnes	265 drams
19 to 20 tonnes	380 drams
20 to 21 tonnes	430 drams
21 to 22 tonnes	700 drams
22 to 23 tonnes	925 drams
23 to 24 tonnes	1,190 drams
24 to 25 tonnes	1,540 drams
25 to 26 tonnes	1,950 drams
26 tonnes and more	1,950 drams plus 55 drams for each tonne above 26 tonnes.

6. Toll for road passage of vehicles with tri-dem axle load exceeding 22 tonnes shall be charged for every kilometre of road passage on the basis of the following tariff rates:

tri-dem axle load	rate
22 to 22.5 tonnes	90 drams
22.5 to 23 tonnes	110 drams
23 to 24 tonnes	175 drams
24 to 25 tonnes	265 drams
25 to 26 tonnes	395 drams
26 to 27 tonnes	550 drams
27 to 28 tonnes	705 drams
28 to 29 tonnes	880 drams
29 to 30 tonnes	1,080 drams
30 to 31 tonnes	1,300 drams
31 to 32 tonnes	1,540 drams
32 to 33 tonnes	1,805 drams
33 to 34 tonnes	2,135 drams
34 to 35 tonnes	2,650 drams
35 tonnes and more	2,650 drams plus 55 drams for each tonne above 35 tonnes.

## Article 7. Tariff rates for large motor vehicles road passage

1. For the purposes of this Law, heavy motor vehicles shall include vehicles in which at least one of the following dimensions (including cargo dimensions) exceeds:

road surface clearance	- 4 metres;
width	- 2.5 metres;
length with one trailer (semi-trailer)	- 20 metres,
with two or more trailers	- 24 metres.

Vehicles whose cargo load is extended from the vehicle back line by more than 2.5 metres shall be considered large vehicles.

2. Toll for road passage of large vehicles shall be charged for every ten kilometres of road passage in the amount of 110 drams.
