<p><b>Goods:</b></p> <p>Foreign drivers of freight vehicles performing international road transport are not prohibited to come to Bosnia and Herzegovina. Border checks may include health checks.</p>			In the case of international transit transportation of cargo by road, the time spend on the territory of B&H is restricted to a period not exceeding 12 hours from the moment of entry into the territory of the B&H.	
<p><b>Passengers:</b></p> <p>Foreign people are prohibited to come to Bosnia and Herzegovina from areas with intensive transmission of Covide-19 virus: Province of the People's Republic of China (Wuhan), South Korea, Japan, Italy, Iran, the Republic of France, Romania, Germany, the Republic of Austria, Spain, Switzerland and Belgium.</p>		30.03.2020		

<p><b>Other:</b></p> <p>There is no special traffic ban at international border crossings except at border crossings closed by neighbouring countries.</p>
