

## MEASURES INTRODUCED IN MEMBER COUNTRIES RELATED TO COVID-19

**Country: Croatia**

**Date: 24/04/2020**

### TRANSIT TRANSPORT

To ensure protection of the Republic of Croatia population from coronavirus, the Civil Defence crisis committee took the decision on the transit border crossings for goods vehicles in transit through the territory of the Republic of Croatia.

Following border crossings will be open for goods vehicles in transit through the Republic of Croatia in absence of direct routes toward the countries of destination:

- the border between the Republic of Croatia and the Republic of Slovenia: Bregana and Macelj border crossings;
- the border between the Republic of Croatia and Hungary: the Goričan and Duboševica border crossings;
- the border between the Republic of Croatia and Bosnia and Herzegovina: the Nova Sela, Stara Gradiška and Slavonski Šamac border crossings;
- the border between the Republic of Croatia and the Republic of Serbia: the Bajakovo border crossing.

Transport services in transit through the territory of the Republic of Croatia shall be carried out using motorways. Routes of movement, stopping points and fuel points will be determined by police authorities. Drivers of goods vehicles shall adhere to the instructions from police officers and civil defence members.

When stopping, drivers shall observe strict distancing measures and shall avoid close personal contacts (2 meters indoors and 1 meter outdoors).

### QUARANTINE AND SELF-ISOLATION

After loading/unloading of goods, drivers may stay in self-isolation at their own homes, with full adherence to all self-isolation measures. They may carry out further transport activities as requested by their employers without being subject to respecting time limits of self-isolation.

If the drivers notice the symptoms of COVID-19, they should contact without delay their family doctor for further instructions.

If the drivers are not able to stay in home isolation after loading/unloading of goods, they may use quarantine/self isolation premises provided by their employers and previously approved by local civil defence authorities.

In cases where their stay in quarantine is shorter than 24 hours, the drivers of goods vehicles shall take their daily rest on board the vehicle within their employer's parking area. If, for objective reasons, the drivers of goods vehicles in international transport are not able to stay in home isolation or in quarantine/isolation premises provided by their employer, they may use in the quarantine/self-isolation premises provided by county civil defence authorities.

In cases where their stay in quarantine is shorter than 24 hours, the drivers of goods vehicles shall take their daily rest on board the vehicle within the parking area of the quarantine.

Non-resident drivers are not subject to health monitoring measures if they leave the territory of the Republic of Croatia immediately after unloading. If they are staying longer than 24 hours, they may use county quarantine premises.

During their stay in home isolation or in quarantine/self-isolation premises provided by the employer or by county civil defence authorities, the drivers shall adhere to the relevant self-isolation measures.
