It should be noted in addition, that Finland allows to large extent e-learning and such an information is not collected in a detailed level Firstly, the driver performs an initial qualification training for professional competence which includes the exam: after that the driver maintains it with periodic training in a five year's period. Finnish Transport and Communications Agency(Traficom) has the overall number of all drivers having the valid CPC in Finland, so that it knows how much Finland has qualified drivers (but does not separate them). Also, Agency uses a subcontractor in organising examination, based on national law, which makes collection of information more complex. .The system administered contains only the information regarding qualified drivers.
