* - By the Law on Carriage in Road Transport ("Official Gazette of Montenegro" No 71/2017 and 67/2019), Article 12 paragraph 5 the initial, accelerated initial, reduced initial training and periodic training of the drivers and passing the exam for examining the knowledge acquired at initial, accelerated initial and periodic training shall be carried out by the Chamber of Economy of Montenegro.

** - By the Law on Carriage in Road Transport ("Official Gazette of Montenegro" No 71/2017 and 67/2019), Article 22 paragraph 7 Vocational training and the professional competence examination shall be carried out by the Chamber of Commerce and issued a Certificate of professional competence for manager in international or national road transport. Chamber of Economy of Montenegro has as well IRU Academy accreditation.

*** - Center for Road Transport Education of the Chamber of Economy of Montenegro has also IRU Academy accreditation.
