Note: The records maintained by the Road Traffic Safety Agency do not separate periodic training for goods transport and passenger transport. This number represents the total number of all drivers who attended periodic training during one year.

The training system for professional drivers in the Republic of Serbia was established at the beginning of 2020, when the first training centres were formed. With further development and an increase in the number of authorised training centres (as well as legal restrictions that the driver cannot attend all five knowledge improvement seminars at once, i.e. 35 hours of periodic training, but that he can attend a maximum of two seminars during one calendar year), driver attendance to the trainings increased significantly in 2021- 2022. It is expected that in the coming period, until the end of 2023, there will be a significant increase in the attendance of drivers at training sessions, because in 2024, the first cycle of 5 years of validity of cards and certificates of professional competence of drivers(CPC) ends, when drivers must renew their cards.
