Other useful information:

* Slovenia has authorized examination (training) centres to carry out the obtaining of CPC and periodic training for drivers, by decision of the Minister responsible for transport, on the basis of a public tender. Therefore, all listed training centres work under the authority of the Ministry for Infrastructure, the tests (practical and theoretical) are carried out by the independent examination board appointed by the Minister and all CPC are issued by the Ministry of infrastructure and signed by the the Chair of the independent examination board appointed by the Minister.

** The same system is implemented for obtaining the CPC manger, with the difference that only one organization (INTER-ES) is authorized.

CPC Manager and CPC Driver models are compliant with EU Regulations.

See ANNEX 1 . CPC Driver and CPC Manager Models

In accordance with Article 10 of the Directive 2022/2561 the code 95 could be marked on the driving licence if the driver has normal residence in Slovenia basis or he works in Slovenia. If neither of these two conditions is fulfilled the code 95 is marked on the driver qualification card. For a driver who drives vehicles used for the carriage of goods by road it is also allowed to indicate the code 95 on the driver attestation provided for in Regulation (EC) No 1072/2009.

CPC manager model is compliant with the requirements of Annex III of Regulation (EC) No 1071/2009.
