Determined civil flights departing from the territory of another state and landing in the territory of the Slovak Republic have been banned with some exemptions. Entering the Slovak Republic by crew and passengers: The pilot-in-command or commander of the aircraft flying into the airspace of the Slovak Republic and landing at the airport in the territory of the Slovak Republic has to hand over the general declaration after landing at the first airport in the territory of the Slovak republic. All passengers disembarking, including transfer passengers, at the airport in the Slovak Republic from the aircraft that conducts flight into the airspace of the Slovak Republic and lands at the airport in the territory of the Slovak Republic fulfill flight and personal data in the public health passenger locator form. Air carriers and other aircraft operators have to keep the data for identification and contact details of passengers and seating plans available to them for flights into the airspace of the Slovak Republic for minimum 30 days. All persons who enter to the territory of Slovak Republic who visited a country other than Austria, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, Germany, Greece, Hungary, Iceland, Latvia, Liechtenstein, Lithuania, Malta, Norway, Slovenia, Switzerland, Montenegro, Monaco, Faroe Islands, Poland during the previous 14 days, they must present when crossing the borders of the Slovak Republic a negative result of the RT-PCR test (confirmation of the negative test) to the disease COVID-19 not older than 96 hours to a member of the Police Force of the Slovak Republic. Alternatively, after entering the territory of the Slovak Republic through the border crossings at which are not checked, the negative result must be handed over without delay result at the relevant regional public health authority.
