INTRODUCTION

This note presents the proposed preliminary programme for the 2018 ITF Summit on *Transport Safety and Security* which will take place from 23 to 25 May 2018 in Leipzig, Germany. The Summit will be held under the Presidency of Latvia, with Korea as first vice-president and Ireland as second vice-president.

The preliminary programme features the overall themes and ideas as presented in the document 2018 Summit Scope [ITF/TMB/TF18(2016)1], and discussed by the 2018 Task Force at its first meeting on 26 October 2016 in Mexico City.

The programme also incorporates feedback provided by individual countries, reflections from the Secretariat, as well as initial input from stakeholders received during the ITF Consultation Day with International Organisations which took place in December 2016. These considerations are reflected in the map of Summit key themes attached in Annex 1.

The Secretariat is finalising the 2017 Summit's evaluation, both internal and external, including a number of surveys to member countries, Summit participants, and key stakeholders such as sponsors, exhibitors, and side events' organisers. The results of this evaluation will also enrich the reflection on the 2018 Summit programme.

1. Summit programme: structure and format

In terms of the structure, it is proposed that the overall programme remains largely the same as in previous years: the Summit will run through two and a half days (Wednesday morning to Friday mid-day), featuring both Ministerial sessions (closed and open events) and open policy debates/sessions, driven by member countries and ITF stakeholders.

The Secretariat proposes that the 2018 Summit continues to provide a range of special features and discussion formats, including:

- Plenary debates and parallel sessions.
- Open Ministerial session.
- Interactive panel formats (such as breakfast and lunchtime sessions, Masterclass session).
- ITF in focus sessions.

The Secretariat will also explore possibilities of using other innovative session formats such as debates and "world café-style" sessions (i.e. conversation tables in small groups).

In order to enhance interactive dialogue and engagement with participants, the Secretariat will aim to plan small panels (4-5 speakers and a moderator) and diverse in terms of gender and geographical representation.

It is also suggested to continue with the approach in 2017 to schedule a maximum of two open sessions during the same time period (i.e. not including restricted/closed sessions and side events), noting that other meetings and bilaterals also take place during these times.

The Secretariat will prepare a detailed proposal defining the Summit session formats, once the substantive discussion for each session is developed, thus allowing for flexibility and tailoring. The proposal will be presented at the next Task Force meeting on 8 November 2017.

Ministers' Roundtables

Regarding the topics for the Ministers' Roundtables (MRTs), the Secretariat proposes to follow the same process as was successfully employed in the past two years. This process, which created smaller working groups to define a specific topic based on a high-level theme approved by Task Force, proves to be an effective approach to ensure that relevant and topical issues are defined.

Side events, technical and cultural tours

The Secretariat will work with external stakeholders to organise side events, technical and cultural tours as part of the Summit programme. Slots for these events have been tentatively included in this proposed structure, as this information will support the Secretariat in beginning communications with potential hosts and organisers of these events.

Summit-related events: Pre-Summit research day key partner events, side sessions

The Summit serves as a platform for the ITF to engage with its broad range of stakeholders (i.e. international organisations, business, civil society, academics) in an open and responsive way. In particular, the Summit-related events provide opportunities for ITF stakeholders to present their views, showcase their work, and be involved in the debate.

Transport Research Day

The 2017 Summit successfully featured the pre-Summit Transport Research Day which was organised in cooperation with the World Conference on Transport Research Society (WCTRS). The Research Day attracted the transport research community, including members of the WCTRS and other academic fora, as well as representatives of think tanks, government, and industry. For the 2018 Summit, the Secretariat is also planning to organise a pre-Summit research Day, in partnership with the research community.

2. Proposed preliminary programme

The proposed preliminary programme is presented in Table 1. Following feedback from Task Force members during this meeting as well as further development by the Secretariat, the programme will be presented at the November meetings for final review by the 2018 Task Force, followed by approval by the TMB.

Please note that the session titles are working titles only; the Secretariat will develop more communicative titles for the sessions for the next Task Force meeting on 8 November 2017.

Task Force members are asked to consider the proposed programme and provide feedback, including on the bulleted list of possible questions/ issues for discussion.
