# **Toyota joins Corporate Partnership Board**

World's largest car manufacturer in 2015 to work with International Transport Forum on important topics such as shared mobility and decarbonising transport

Toyota Motor Corporation, the world's biggest car manufacturer, has joined the Corporate Partnership Board (CPB) of the International Transport Forum (ITF). As part of its involvement, Toyota will focus on projects around shared mobility and decarbonising transport.

The ITF is an intergovernmental organisation with 57 member countries that facilitates global dialogue for better transport. It acts as a think tank for member governments and organises an annual summit of transport ministers. The CPB is the ITF's platform for engaging with the private sector and to enrich global transport policy discussion with a business perspective.

Toyota, based in Toyota City, Aichi, Japan, has been building cars since 1937. In the 2015 financial year, the company sold almost 9 million vehicles, making it the world's largest car manufacturer by sales. Toyota is also world market leader in hybrid electric vehicles, with more than 9 million units sold as of April 2016. The company is famous for pioneering quality-focused manufacturing and just-in-time production. Toyota is active in over 170 countries and in 2015 employed 350 000 people worldwide.

José Viegas, Secretary-General of ITF, welcomed Toyota to the CPB:

"Toyota is the embodiment of a great tradition imbued with the spirit of innovation. The company's success in bringing ground-breaking innovation like hybrid cars to market is admirable and rooted in Toyota's constant drive to improve the way it delivers mobility for people around the world.
