# ON APPROVING THE LIST OF INFRINGEMENTS RELATED TO TRANSPORT ACTIVITIES ENTAILING LOSS OF BUSINESS REPUTATION

Guided by part 14 of Article 7 of the Law "On road transport", the Government of the Republic of Armenia hereby *decides:* 

- 1. To approve the list of infringements related to transport activities entailing loss of business reputation, pursuant to the Annex.
- 2. This Decision shall enter into force on the tenth day following its official promulgation.

### LIST

## OF INFRINGEMENTS RELATED TO TRANSPORT ACTIVITIES ENTAILING LOSS OF BUSINESS REPUTATION

- Infringements entailing loss of business reputation of an undertaking shall be the serious infringements committed by the undertaking or the transport manager thereof, for which they have been subjected to criminal or administrative liability in the following spheres:
  - (1) commercial law;
  - (2) ensuring of road traffic safety;
  - (3) trafficking;
  - (4) traffic of narcotic drugs and psychotropic (psychoactive) substances;
  - (5) complying with the requirements by the personnel for driving a motor vehicle and for rest periods and the requirements of the legislation on the use of digital tachographs;
  - (6) more than one infringements of the requirements for the maximum permissible laden mass of vehicles carrying out international haulage and/or the load on one axle, as well as maximum sizes of large dimensions in the course of one year;
  - (7) infringements in the sphere of ensuring of road traffic safety.
- 2. The infringements of the requirements by the personnel for driving a motor vehicle and for rest periods and the requirements of the legislation on the use of digital tachographs according to level of seriousness shall be very serious, serious and minor.

- 3. Very serious infringements shall be the infringements that pose a risk for road traffic safety and contain a risk of causing the death of or serious damage to the health of participants of traffic.
- 4. The list of infringements of the requirements by the personnel for driving a motor vehicle and for rest periods and the requirements of the legislation on the use of digital tachographs entailing loss of business reputation of an undertaking according to level of seriousness thereof, are presented in Table 1.

- (1) very serious infringements: 1
- (2) serious infringements: 3
- (3) minor infringements: 4
- 6. Where the undertaking or the transport manager thereof commits the infringements provided for in point 5 of this Procedure in the course of one year, the undertaking shall be considered as high-risk.
- 7. In the course of the two years after commission of the infringement by the high-risk undertaking prescribed in point 6 of this Procedure the inspection body carrying out supervision in the transport field shall, at least once a year, organise audit, as a result of which the undertaking shall lose its business reputation in case infringements are recorded again.
