Dear Ms Elena,

Bearing in mind that Montenegrin drivers are required in a certain number of European countries to possess a Professional Driver License, we use this opportunity to ask you kindly to make ITF members acquainted with the following information.

After new Law on Road Transport in Montenegro ("Official Gazette of Montenegro" No. 71/2017) come into force, Montenegro began to issue Certificates of Initial Qualifications and Certificates of Accelerated Initial Qualifications.

Furthermore, our plan is that by the end of the first quarter of 2019. We will start issuing Professional Driver License (Driver Qualification Card), on the basis of these certificates.

In connection with the above, it is important to point out that until the beginning of the issuance of a Professional Driver License, our drivers possess Certificate of Initial Qualifications Certificates or Certificates of Accelerated Initial Qualifications, which are issued on the forms attached to this Act, which are in conformity with forms defined by the IRU Academy.
