The Annual Summit of Transport Ministers

The International Transport Forum (ITF) at the OECD is an intergovernmental organisation with 64 member countries. Based in Paris, it is the only global body with a mandate to advance transport policy for all modes of transport.

Every May, ministers of transport from ITF member and guest countries meet for their Annual Summit in Leipzig, Germany. The Summit, often referred to as the “Davos of Transport”, is the **premier global transport policy event** and gathers political decision-makers, heads of international organisations, CEOs, and other leaders from business, civil society, media and academia.

Each year, more than 1400 participants share their views and **debate the future of transport and mobility**.
