Dear Mr. Kim,

I have the honor to present my compliments to you personally and to the International Transport Forum, and address with the following.

For 2024, the distribution of ECMT permits for Ukraine is as follows: Euro-5 is 2,750 units; Euro-6 is 2800 units.

However, according to the available information, in addition to this quota of Euro-6 permits, 481 permits were mistakenly printed with the "Euro-6" mark, although these erroneous permits correspond to the permits for the "Euro-5" category.

According to clause 6.4 of the ECMT Multilateral Quota User Guide, forms of a lower category are allowed to be used for vehicles of a higher category.

With this in mind, we would like to provide a list of 481 permit numbers of the Euro-6 category, which we kindly ask to consider as Euro-5 category permits. The number ranges are as follows: 161-186, 682-717, 993-1073, 1123-1145, 1546-1564, 1849-1864, 1946-2005, 2831-2852, 3145-3159, 3448-3470, 3661-3739, 3921-3959, 5019-5060. This does not contradict the ECMT norms and will allow not to reprint forms that were printed with an error.

In the case of a positive decision, please convey the relevant information to all ECMT member countries and their regulatory public bodies.

We deeply apologize for this situation, and we will do our best to prevent similar situations in the future.

Let me avail myself of this opportunity to renew, to you and to the International Transport Forum, the assurances of my highest consideration and express hope for further fruitful cooperation.
